



TERMS OF REFERENCE

Software Developer- Domestic Violence Case Management System (Reference Number: (IUL)450-CA/1/2019/4)

1. Objectives:

The specific objectives are:

- 1) Developing a fully responsive user interface with sufficient validation and verification methods on the user input fields. Usage of a stable rapid development framework is acceptable.
- 2) A good dataflow of the respective system that prevents any possible confusion of usage.
- 3) Automation wherever possible to make the entry and retrieval process faster and more reliable.
- 4) Consistency throughout the respective systems.
- 5) The system must be developed using free open-source technology. And it must be compatible with Linux/Unix servers without requiring any additional cost.
- 6) A good error reporting system that relies on a REST API.
- 7) Graphical representations of the data entries to be generated as statistical reports.
- 8) The user interface should be able to use multiple font-faces. (Dhivehi fonts inclusive).
- 9) The front-end of the system should be a single-page application. User-interface should use REST API (Representational State Transfer Application Program Interface) calls to connect to the MMVC (Module Model View Controller) controllers of the respective systems.

2. Profile of Contractor:

- (a) **Education**: Bachelor's degree in Software Engineering or Information Technology or Computer Science.
- (b) Work experience: 4 years' experience in software development.
- (c) **Language**: Excellent written and oral communications skills in both Dhivehi and English.
- (d) Excellent understanding of HTML (Hypertext Markup Language), CSS (Cascading Style Sheets), and JavaScript (jQuery would be an added bonus).
- (e) Excellent understanding of the REST API concept.
- (f) Good understanding on how MVC (Model View Controller) architecture works.
- (g) Excellent understanding of JSON (JavaScript Object Notation) data manipulation.
- (h) Good communication skill.





3. Work Setting:

- (a) Place: Family Protection Authority, Male', Maldives
