		(d)	Monitor and report to any person designated by the Minister in a format approved by the Minister, the progress of activities designed and conducted at island level to implement the Domestic Violence Act and the regulations thereunder.
		(e)	Conduct awareness programs against domestic violence, and engage Women's Development Committees of the respective islands, general public belonging to the respective jurisdiction and civil society actors in carrying out other activities related to the cause.
		(f)	Cooperate with Family Protection Authority in implementing the National Strategy for Domestic Violence Prevention.
		(g)	If domestic violence cases which are either reported to the Council or of which the Council receives information about, involves children, the Council shall uphold all principles prescribed in Act no 19/2019 (Child Rights Protection Act) to protect the rights of the children from offences against them.
		(h)	Conduct awareness programs to the public in collaboration with the Family Protection Authority to raise awareness about identifying and preventing domestic violence and aiding the victims of domestic violence.

		(b)	Pursuant to subsection (a) of this section, being considerate of the number of employees working in the office of the Council, each Council shall appoint one or two employees for this purpose. This section does not prohibit the employees appointed herein to be the Council representatives in "IBAMA".
		(c)	The responsibilities pertaining to attending to domestic violence cases by the employees appointed under subsection (b) of this section, shall be included in their job description.

		(e)	This section does not prohibit the appointed employee under this section to be an elected member of the incumbent Council.
		(f)	Councils which have not appointed any employee to attend to domestic violence cases reported to the Council or which comes to the attention of the Council and wherein other authorities have requested assistance in accordance with subsection (a) of this section, such appointment shall be made within 30 (thirty) days from the date of commencement of this Regulation and inform the same to the Family Protection Authority in accordance with this section.
Budgeting	15	(a)	Notwithstanding section 9(a) of this Regulation, this Regulation does not prohibit the Councils from apportioning an estimated amount required to respond to domestic violence cases and deliver assistance requested by other authorities from the budget allocated for social services in the Council's annual budget.
		(b)	In estimating the amount required to address domestic violence cases, the size of the population of the island, alternative support mechanisms available in the island to the public in domestic violence cases, the assistance that Council has previously provided and the projected programs by the Council to prevent such cases shall be taken into consideration.
Conducting required trainings	16	(a)	Responsibilities under this Regulation shall be assigned to Councils after the staff of each Council is trained in relation to domestic violence.
